Acquisition proposals are considered by the Director, Ipswich Art Gallery in consultation with the Exhibitions & Collection Manager and the Ipswich Arts Foundation Trust, and in accordance with the Collection development themes outlined in the City of Ipswich Collection policy.

When appraising acquisition proposals, the key considerations include:

- aesthetic merit and quality
- relevance to the Collection directions and/or exhibition program
- condition of the item
- storage and display practicalities
- significance to the cultural and social heritage of Ipswich
- reflective of the community's attributes and aspirations, including its multi-cultural Indigenous Australian communities
- supports the institutional strengths of Ipswich Art Gallery, such as programs for children

***City of Ipswich Collection***

The City of Ipswich Collection at the Ipswich Art Gallery provides inspiration and aesthetic enrichment, it educates and enlightens, it builds greater understanding of others in the community, and it is a source of civic pride and identity.

The Ipswich Art Gallery presents a balanced program of entertaining, educational, and culturally significant art and social history exhibitions. The program includes displays of visual art, craft, design, social history and related areas of interest, including both historical and contemporary material. The range of exhibitions reflects a commitment to presenting a diversity of artists and media, including painting, printmaking, drawing, sculpture, decorative arts, installation, photography, video, film and digital media.

***Media***

Information concerning new acquisitions will be made available to the media when formally approved by Council with due recognition given to donors and other supporters of the acquisition. Donors and vendors who wish to remain anonymous should inform the Gallery.

***Community Standards***

In its endeavours to maintain good relations with the community the Ipswich Art Gallery will not acquire art works or historic objects where the content or theme may cause undue offence to the community or to particular community groups.
